General Business:

1. Kerikeri Squash Club:

The Board welcomed Dave Collins and Rick Shrubshaw, Members of the Kerikeri Squash Club to the meeting.

Dave advised the resource and building consents have been issued by Council. Costs to build the facility have escalated and are now in the vicinity of \$1.4 million. Squash is looking for different cost saving options in their initial design and would like to propose the joint use of Netball's women's ablution facility with the Squash Women.

Dave will forward a letter of proposal to the Kerikeri Netball Centre.

Squash previously applied to Foundation North for funding but their application was declined.

When asked about building only two courts instead of the proposed four, Squash felt it was financially better to build the shell for four and perhaps only fit out two at the initial stages.

Dave and Rick left the meeting at 6.40pm.

2. Playground update:

Ange has lodged a funding application for \$10,000 with the Oxford Trust. KKRC have granted \$5,000 and KKNC have guaranteed \$2,500 over two years. Other companies have come on board with donations `in kind' including a \$9,000 donation from Ninety Degree Kitchens. Recreational Services Limited have offered a donation of \$8,000. The account is almost up to \$43,000 in total.

Ange will organise some A3 plans to be displayed on the notice board inside the function room and other places around the complex grounds.

3. AGM:

4. Fire evacuation training programme:

The Board Members present completed an emergency fire drill in accordance with the Fire Evacuation Training Program as prepared by the Far North District Council. There were no areas of concern and members were able to evacuate the building in 5 minutes from the alarm sounding.

6. 2021-2022 Fees:

The members agreed that the hireage fees remain as per status quo for the 2021/2022 financial year. However some rates needed adjustment so as to be consistent throughout the fee schedule.

As from April 1, 2021 a bar tenders fee of \$100 will apply to all bookings of non-affiliated members. The Coordinator will notify KKRC who will issue an invoice to the KSC.

7. Kerikeri Sports Complex – Emergency Evacuation Site: Kerikeri Sports Complex is not an official community centre in the event of an emergency however the Board Members would like to offer the Complex facilities and begin the process to become an official site. The Coordinator will liaise with Bill Hutchinson, Civil Defence Officer, NRC.

A master key will be left with Riverview Primary School so they may gain access in the event of an emergency. The Coordinator will contact Bay Lock n' Alarm to organise this.

- 8. North Able booking enquiry:
 - North Able is potentially looking for a premises to hire one day a week for the next two years to run activities, games, crafts etc. for approximately 20 people with disabilities. The hireage rate is the current commercial rate of \$30 per hour inclusive gst plus a \$200 refundable bond and any kitchen hireage fees. The Coordinator will meet with North Able on Thursday, April 22nd to view the premises.
- 9. Monty Walker's wedding booking enquiry:
 - The Board approved Monty's booking enquiry to use the premises for his wedding on the weekend of March 12, 2022. The hireage fee is \$575.00, a \$500 refundable bond, \$100 for bar staff and all liquor licence associated fees. The Board requested that Monty confirm his booking as soon as possible so Rugby can have plenty of notice when planning their preseason games for 2022.
- 10. Kim Tipene Te Roopu Taurima O Manukau Trust booking enquiry:
 The Board approve in principle the booking enquiry from the Te Roopu Taurima O Manukau
 Trust to use the premises on Thursday/Friday July 8/9 to hold a Ball for their members with
 disabilities. As this booking coincides with yoga classes, the Coordinator will talk
 with Lisa and see if she is flexible to the Trust using the premises on Friday morning.

The normal hireage fee would be \$575.00 inclusive gst plus a refundable bond and any other associated costs. However, the Board would like to offer a \$150 discount to the Trust. The Coordinator will prepare a comparison of costs as it may prove more financially viable for the Trust to hire the premises on an hourly basis.

Brad Te Haara – Northland Rugby Union: Brad would like to hire the fields & lights, changing sheds & showers Wednesday 19, 26, Monday 31 May & Wednesday, 2 June for North Zone HP trainings. Graham will take this to the KKRC meeting on Tuesday, April 13.
